Technology Readiness Level

- Prototype ready (form, fit and function) for demonstration in an appropriate operational environment. At this level, the prototype should be at an operational level and ready for demonstration. Activities include prototype field testing.
- Actual technology completed and qualified through test and demonstration. At this level, the technology has been proven to work in its final form and under expected conditions. Activities include developmental testing and evaluation of whether it will meet operational requirements.
- Actual technology proven through successful operations. At this level there is actual application of the technology in its final form and under real-life conditions, such as those encountered in operational test and evaluations. Activities include using the innovation under operational conditions.
- Technology does not meet any of the three previous descriptions, but we are working towards it.

- What infrastructure and supply chain risks exist and how they are managed.

Mandatory Criteria

The following criteria are mandatory requirements for all participants. By selecting the following criteria, you are certifying that the statement is true of your business. The Applicant:

- is a for profit business;
- is an incorporated business in Saskatchewan (incorporation can take place either federally or provincially);
- has 30 or fewer Full-Time Equivalent (FTE) employees;
- has less than \$500,000 in annual revenue; and,

- pays at least 50% of its annual wages, salaries, and fees to employees and contractors who spent a majority of their time working in Saskatchewan.

After the initial review of your application, Innovation Saskatchewan will request access to your product or service, so it can be reviewed by our technology advisory panel.
